<b>Special Remarks on Chronic Effects on Humans</b>	Prolonged or repeated contact with skin can cause defatting and drying of the skin resulting in skin irritation and dermatitis. Prolonged exposure to high vapour concentration can cause headache, dizziness, nausea and central nervous system depression. High level exposure to Xylene in laboratory animals, often at levels which are toxic to the mother, have affected the development of the fetus. The relevance of this to humans is not known. <b>Special Remarks on Other Toxic Effects on Humans</b>	Material is irritating to mucous membranes and upper respiratory tract. Small amounts of liquid aspirated into the respiratory system during ingestion or from vomiting may cause mild to severe pulmonary injury and possibly death. Material is irritating to mucous membranes and upper respiratory tract. (Benzene, dimethyl-)
